



### **ASDA Pension Proposals**

#### **Fair Pensions for All**

The ASDA managers' pension provides for 5x Death in Service and up to 7% or 10% matched contributions from ASDA.

The ASDA hourly paid colleagues Step Up section currently provides for 4x Death in Service and up to 3% matched contributions from ASDA.

ASDA is proposing to close the Step Up Scheme for hourly paid colleagues.

This means

- Death in Service will reduce from 4x to 1x pay and
- ASDA's pension contributions will be reduced

The gulf between Managers and Hourly Paid Colleagues Pensions isn't fair.

ASDA should drop the proposals

Hourly Paid Colleagues and Managers deserve a decent pension. GMB believes in fair pensions for all.
